Section 6. Accidental release measures

Large spill

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Add the same decontaminant to the remnants and let stand for several days until no further reaction in an unsealed container.
