Section 5. Fire-fighting measures

Extinguishing media

Methods and materials for containment and cleaning up

Section 7. Handling and storage

Precautions for safe handling

Recommended monitoring procedures : Reference should be made to appropriate monitoring standards. Reference to national guidance documents for methods for the determination of hazardous substances will also be required.

Appropriate engineering controls : Use only with adequate ventilation. Prolonged or repeated contact may dry skin and cause irritation.
