6. Accidental release measures

Environmental precautions: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Methods and materials for containment and cleaning up

Small spill

8. Exposure controls/personal protection

Appropriate engineering controls
