5.1 Extinguishing media

5.2 Special hazards arising from the substance or mixture

5.3 Advice for firefighters

7.1 Precautions for safe handling

Protective measures : Put on appropriate personal protective equipment (see Section 8). Appropriate engineering controls : Use only with adequate ventilation. Hygiene measures
