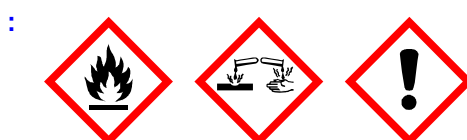

## SECTION 6: Accidental release measures

### 6.1 Personal precautions, protective equipment and emergency procedures

## SECTION 8: Exposure controls/personal protection

### 8.2 Exposure controls
