Section 5. Fire-fighting measures

Methods and materials for containment and cleaning up

Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Precautions for safe handling
