Section 4. First aid measures

Description of necessary first aid measures

Section 5. Fire-fighting measures

Extinguishing media

Specific hazards arising from the chemical : Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. Methods and materials for containment and cleaning up

Precautions for safe handling

- Protective measures

: Put on appropriate personal protective equipment (see Section 8). Avoid exposure - obtain special instructions before use. Avoid exposure during pregnancy. Appropriate engineering controls : Use only with adequate ventilation.
