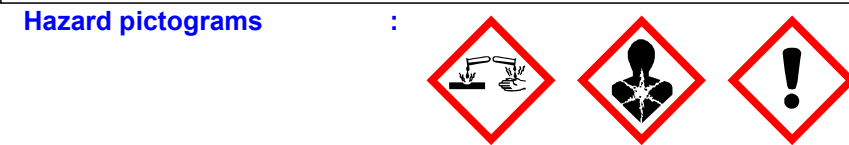

This product contains TiO₂ which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification.
