This product contains TiO<sub>2</sub> which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. ## Section 7. Handling and storage

### Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8).
