Extinguishing media

Methods and materials for containment and cleaning up

Precautions for safe handling

Section 8. Exposure controls/personal protection

- Appropriate engineering controls** : Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. Other information :

Prolonged or repeated contact may dry skin and cause irritation.
