SECTION 4: First aid measures

4.1 Description of first aid measures

4.3 Indication of any immediate medical attention and special treatment needed

Hazards from the substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. 6.1 Personal precautions, protective equipment and emergency procedures

Appropriate engineering controls : Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
