Section 5. Fire-fighting measures

Extinguishing media

Methods and materials for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures

Conditions for safe storage, including any incompatibilities : Do not store above the following temperature: 50°C (122°F). Store in accordance with local regulations. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers.
