Section 4. First aid measures

- A. Eye contact** : Remove contact lenses, irrigate copiously with clean, fresh water, holding the eyelids apart for at least 10 minutes and seek immediate medical advice.

Section 5. Fire-fighting measures

A. Extinguishing media

Suitable extinguishing media : Use dry chemical, CO₂, water spray (fog) or foam.

B. Specific hazards arising from the chemical : Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. C. Methods and materials for containment and cleaning up

Large spill

A. Precautions for safe handling

Do not enter storage areas and confined spaces unless adequately ventilated. Eliminate all ignition sources. Separate from oxidizing materials. Keep container tightly closed and sealed until ready for use. B. Appropriate engineering controls : Use only with adequate ventilation.
