Description of necessary first aid measures

SECTION 7: Handling and storage

Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8). If during normal use the material presents a respiratory hazard, use only with adequate ventilation or wear appropriate respirator.
