Section 4. First aid measures

Description of necessary first aid measures

Section 5. Fire-fighting measures

Extinguishing media

Specific hazards arising from the chemical : Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. Precautions for safe handling

Protective measures

Recommended monitoring procedures : Reference should be made to appropriate monitoring standards. Reference to national guidance documents for methods for the determination of hazardous substances will also be required.

Appropriate engineering controls : Use only with adequate ventilation.
