During non-atomizing spraying in existing* facilities of the combined-cabin, spray-cabin and spray-booth type where the operator is working inside the spray zone. During downtimes, cleaning and repair of closed facilities, spray booths or cabins, if there is a risk of contact with wet paint or organic solvents. - Air-supplied full mask and protective clothing must be worn. During all spraying where atomization occurs in cabins or spray booths where the operator is inside the spray zone and during spraying outside a closed facility, cabin or booth.	Not applicable.

Drying: Items for drying/drying ovens that are temporarily placed on such things as rack trolleys, etc. must be equipped with a mechanical exhaust system to prevent fumes from wet items from passing through workers' inhalation zone.

Polishing: When polishing treated surfaces, a mask with dust filter must be worn. When machine grinding, eye protection must be worn. Work gloves must always be worn.
