Section 4. First aid measures

Extinguishing media

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

- For non-emergency personnel** : ☒ No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Methods and materials for containment and cleaning up

Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8). Avoid exposure during pregnancy. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Appropriate engineering controls : Use only with adequate ventilation.
