### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

**Small spill** : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. ## SECTION 6: Accidental release measures

### Precautions for safe handling

## SECTION 8: Exposure controls/personal protection
