

## Section 5. Fire-fighting measures

A. Extinguishing media

Suitable extinguishing media

B. Specific hazards arising from the chemical

: Mammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. - A. Precautions for safe handling
