It contains low-molecular weight epoxy constituents which are irritating to eyes, mucous membranes and skin. Repeated skin contact may lead to irritation and to sensitization, possibly with crosssensitization to other epoxies. Skin contact with the mixture and exposure to spray, mist and vapors should be avoided.
