#### **SECTION 4: First aid measures**

#### 4.1 Description of first aid measures

**Eye contact** : Check for and remove any contact lenses. Immediately flush eyes with running water

for at least 15 minutes, keeping eyelids open. Seek immediate medical attention.

Large spill

#### 7.1 Precautions for safe handling
