### SECTION 6: Accidental release measures

#### **Special provisions**

Eontain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). #### **Conclusion/Summary**
