There are no data available on the mixture itself. Contains lead. Exposure to lead dust and fumes adversely affects blood and blood forming tissues, kidneys, liver, the central/peripheral nervous systems and male/female reproductive organs. Lead exposure causes adverse developmental effects including brain damage in children and unborn fetuses. Carbon black is utilized as a raw material in many liquid coating formulations. In this case, the carbon black particles are bound in a matrix with no meaningful potential for human exposure to unbound particles of carbon black when the product is applied with a brush or roller.
