## 6. Accidental release measures

- Small spill** : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. ## 7. Handling and storage

- Precautions for safe handling** : Put on appropriate personal protective equipment (see Section 8).
