Methods and materials for containment and cleaning up

Small spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

Formaldehyde is a known cancer hazard, a skin sensitizer and a respiratory sensitizer. For many PPG products, TiO2 is utilized as a raw material in a liquid coating formulation.
