**SECTION 4: First aid measures****4.1 Description of first aid measures**

<b>Eye contact</b>	: Check for and remove any contact lenses. Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open. Seek immediate medical attention.

**SECTION 8: Exposure controls/personal protection**


