## **SECTION 4: First aid measures**

## 4.1 Description of first aid measures

**Eye contact**: Check for and remove any contact lenses. Immediately flush eyes with running water for

## **SECTION 5: Firefighting measures**

Hazards from the substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. #### 7.1 Precautions for safe handling

#### **Protective measures**
