# **SECTION 5: Firefighting measures**

Hazards from the substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. # **SECTION 7: Handling and storage**

### 7.1 Precautions for safe handling

**Protective measures**

### 8.2 Exposure controls

Appropriate engineering controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
