#### 4.1 Description of first aid measures

**Eye contact**: Check for and remove any contact lenses. Immediately flush eyes with running water for

#### 5.2 Special hazards arising from the substance or mixture

**Hazards from the** substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). #### 7.1 Precautions for safe handling

#### **Protective measures**
