### 8.2 Exposure controls

Appropriate engineering controls

: Use only with adequate ventilation. ### **Skin protection**

**Hand protection** 

: Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when handling chemical products if a risk assessment indicates this is necessary.
