## 6.3 Methods and material for containment and cleaning up Small spill : Stop leak if without risk. Mo

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. ## SECTION 8: Exposure controls/personal protection

Appropriate engineering controls

: Use only with adequate ventilation.
