In this case, the TiO2 particles bound in a matrix with no meaningful potential for human exposure to unbound particles of TiO2 when the product is applied with a brush or roller. Sanding the coating surface or mist from spray applications may be harmful depending on the duration and level of exposure and require the use of appropriate personal prote equipment and/or engineering controls (see Section 8). Exposure to componer solvent vapor concentrations in excess of the stated occupational exposure limit result in adverse health effects such as mucous membrane and respiratory syster fritation and adverse effects on the kidneys, liver and central nervous system.
