Section 4. First aid measures

Description of necessary first aid measures

Section 5. Firefighting measures

Extinguishing media

Personal precautions, protective equipment and emergency procedures

Methods and material for containment and cleaning up

Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Section 7. Handling and storage

Precautions for safe handling

Conditions for safe storage, including any incompatibilities : Store between the following temperatures: 5 to 35°C (41 to 95°F). Store in accordance with local regulations. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers.
