### SECTION 4: First aid measures

### 4.1 Description of first aid measures

: Check for and remove any contact lenses. Immediately flush eyes with running water for Eye contact

Hazards from the substance or mixture

: Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. # **6.2 Environmental precautions**

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product. ### 7.1 Precautions for safe handling

**Protective measures**
