This product contains TiO2 which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. Recommended monitoring procedures	:	Reference should be made to appropriate monitoring standards. Reference to national guidance documents for methods for the determination of hazardous substances will also be required.
