## Section 2. Hazard identification

#### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

## Section 7. Handling and storage

### **Special precautions**

: Ingestion of product or cured coating may be harmful. Vapors may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back. Vapors are heavier than air and may spread along floors.
