#### Section 6. Accidental release measures

#### Personal precautions, protective equipment and emergency procedures

#### For non-emergency personnel

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. ### Section 7. Handling and storage

#### **Special precautions**
