#### 4.1 Description of first aid measures

#### 5.2 Special hazards arising from the substance or mixture

**Hazards from the** substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. #### **Small spill**

#### Large spill

#### **Protective measures**
