### Section 2. Hazard identification

The fluoropolymer resins used in this coating begin to decompose, very slowly, at temperatures above 625°F (330°C). Thermal decomposition is more rapid at temperatures above 750°F (400°C). Above 800°F (425°C) fluoropolymer resins give off small amounts of tetrafluoroethylene / hexafluoropropylene /

perisofluorobutylene / carbonyl fluoride / hydrogen fluoride. These are toxic and if inhaled, in sufficient quantities, may be harmful. The actual decomposition products

depend on temperature and the amount of oxygen.

Special protective actions for fire-fighters

For emergency responders: If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For non-emergency personnel".

**Environmental precautions** 

: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

#### Methods and materials for containment and cleaning up

**Small spill**

Do not enter storage areas and confined spaces unless adequately ventilated. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Store and use away from heat, sparks, open flame or any other ignition source. Use explosion-proof electrical (ventilating, lighting and material handling) equipment. Use only non-sparking tools. Take precautionary measures against electrostatic discharges. Empty containers retain product residue and can be hazardous. Do not reuse container.
