5.3 Advice for firefighters

7.1 Precautions for safe handling

Protective measures

- Put on appropriate personal protective equipment (see Section 8). Do not breathe vapor or mist. Do not ingest. Avoid contact with eyes, skin and clothing. Avoid release to the environment.
