# **SECTION 4: First aid measures**

# 4.1 Description of first aid measures

**Eye contact**: Remove contact lenses, irrigate copiously with clean, fresh water, holding the eyelids

apart for at least 10 minutes and seek immediate medical advice.

# **SECTION 5: Firefighting measures**

Hazards from the substance or mixture

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product. ### 7.1 Precautions for safe handling

#### **Protective measures**
