SECTION 4: First aid measures

4.1 Description of first aid measures

Eye contact: Remove contact lenses, irrigate copiously with clean, fresh water, holding the eyelids

SECTION 5: Firefighting measures

Hazards from the substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. 5.3 Advice for firefighters

Small spill

Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product. 7.1 Precautions for safe handling

Protective measures

8.2 Exposure controls

Appropriate engineering controls
