## 4.1 Description of first aid measures

### 5.2 Special hazards arising from the substance or mixture

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). # 8.2 Exposure controls

Appropriate engineering controls

: Use only with adequate ventilation. Hand protection

: Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when handling chemical products if a risk assessment indicates this is necessary.
