### 4.1 Description of first aid measures

**Eye contact**: Remove contact lenses, irrigate copiously with clean, fresh water, holding the eyelids

#### 5.2 Special hazards arising from the substance or mixture

### 7.1 Precautions for safe handling

**Protective measures**

### 8.2 Exposure controls

Appropriate engineering controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. **Eye/face protection Skin protection**

**Hand protection** 

: Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when handling chemical products if a risk assessment indicates this is necessary.
