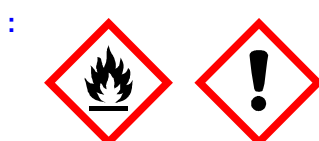

4.1 Description of first aid measures

Small spill

7.1 Precautions for safe handling

Protective measures
