#### Methods and materials for containment and cleaning up

Small spill

**Special provisions**

One possible (flammable) decontaminant comprises (by volume): water (45 parts), ethanol or isopropyl alcohol (50 parts) and concentrated (d: 0,880) ammonia solution (5 parts). A non-flammable alternative is sodium carbonate (5 parts) and water (95 parts). Add the same decontaminant to the remnants and let stand for several days until no further reaction in an unsealed container. #### Precautions for safe handling

#### **Protective measures**

Put on appropriate personal protective equipment (see Section 8).
