5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture : Mammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. 5.3 Advice for firefighters

7.1 Precautions for safe handling

Protective measures

• Put on appropriate personal protective equipment (see Section 8). Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not ingest. Avoid breathing vapour or mist. Avoid release to the environment. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. 8.2 Exposure controls

Appropriate engineering controls
