# Section 2. Hazard identification

This product contains TiO2 which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. ## Consult local authorities for acceptable exposure limits.

Recommended monitoring procedures		Reference should be made to appropriate monitoring standards. Reference to national guidance documents for methods for the determination of hazardous substances will also be required.
