## SECTION 4: First aid measures

### Description of necessary first aid measures

## SECTION 7: Handling and storage

### Precautions for safe handling

The risk of cancer depends on the duration and level of exposure to dust from sanding surfaces or mist from spray applications. For many products, TiO<sub>2</sub> is utilized as a raw material in a liquid coating formulation.
