### 6. Accidental release measures

Environmental precautions: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. #### Methods and materials for containment and cleaning up

#### **Small spill**

# 7. Handling and storage

#### **Precautions for safe** handling
